Application:

- The product is ready to use and does not require thinning.
- Stir the product thoroughly before use and check its homogeneity.
- Apply the product in 2 coats by a brush, roller or spraying. Apply the 2nd coat before 1st coat dries (wet on wet).
- Wait 24 hours for complete dry.
- If it rains during application, cover the applied surface and keep it closed until completely dries.
